Dear North Bergen Resident Permit Holder,

The North Bergen Parking Authority would like to take this opportunity to remind residents that your Residential Parking Permit will be expiring December 31, 2015. New permits are currently available at the Parking Authority office.

**Zone 4 begins at the Guttenberg border and ends at the Fairview and Cliffside Park borders from the East side of Bergenline Avenue to River Road including the Wall Street area, Bulls Ferry Road, Bergen Ridge Road and the Woodcliff Avenue section. (Please see enclosed map.)**

You may begin purchasing permits immediately at the North Bergen Parking Authority office located at 4225 Bergen Turnpike, North Bergen. Our office hours are 8:30 AM to 7:00 PM on Monday and 8:30 AM to 4:00 PM, Tuesday through Friday.

To receive your Residential Parking Permit, resident applicants, who live in this zone, will need to provide the following **ORIGINAL DOCUMENTS: (We no longer can process photocopies).**

- A. Your valid New Jersey driver's license with your name and North Bergen street address, and
- B. Your valid New Jersey vehicle registration with your name and North Bergen street address.

**-Or-**

- A. Your valid New Jersey driver's license, and
- B. Your valid New Jersey vehicle registration, and
- C. Two (2) current utility bills (gas, electric, cable, telephone) with your name and North Bergen street address.

If your vehicle is leased, please also provide your insurance card with your name and North Bergen street address.

The fee for the permit is \$15.00 per vehicle and it will expire December 31, 2018. In addition to accepting check or money orders payable to the North Bergen Parking Authority, cash in the form of "exact change" will be accepted during the registration period.

Please be reminded to check the expiration dates on any daily permits that you might have on hand. If you do not have daily permits with the current year on them, they are no longer valid. New daily permits are available for purchase when renewing your residential decal.
