NOW, THEREFORE, BE IT RESOLVED, by the Commissioners of the Parking Authority of the Township of North Bergen, that the Chairman of the Parking Authority is hereby authorized to enter into agreements, with Allan Roth, Esq. of Roth D'Aquanni and Mark Tabakin, Esq., of Weiner Lesniak, as Labor Counsel, at an hourly rate of \$150.00 per hour, not to exceed \$5,000, respectively, without further authorization, for the provision of legal services, pursuant to the Request for Qualifications and qualifications submitted, a copy of which are incorporated herein and made a part hereof, effective January 1, 2017 through December 31, 2017, or until a successor has been appointed, subject to certification that funds are available; and


