

**RESOLUTION**

**NO.: 2017-038**

**WHEREAS**, a parking area has been developed on Liberty Avenue, at the address of 1707-69<sup>th</sup> Street (hereinafter "Liberty Avenue Lot"); and

**WHEREAS**, pursuant to NJSA 40:11A-6 the North Bergen Parking Authority is authorized to maintain and operate parking facilities under its control and leases said parking area from the Township of North Bergen; and

**WHEREAS**, the Authority desires to permit rental of spaces at the Liberty Avenue Lot to residents of the Township,

**NOW THEREFORE, BE IT RESOLVED** by the Commissioners of the North Bergen Parking Authority, that the foregoing recitals are adopted herein verbatim; and

**BE IT FURTHER RESOLVED** that the Parking Authority shall rent spaces in the Liberty Avenue Lot to residents of the Township with passenger vehicles, at a rental fee of \$90.00 and to resident owners of commercial vehicles, at a rental fee of \$125.00 per month; and

**BE IT FURTHER RESOLVED** that leasing of space for oversized commercial vehicles is hereby prohibited, with the determination as to whether a commercial vehicle is oversized being in the sole discretion of the Parking Authority; and

**BE IT FURTHER RESOLVED** that rents are payable quarterly, in the sum of \$270.00, the 1<sup>st</sup> day of the month beginning the quarter, for passenger vehicles and \$375.00, the 1<sup>st</sup> day of the month beginning the quarter, for commercial vehicles, as follows: January 1<sup>st</sup>, April 1<sup>st</sup>, July 1<sup>st</sup> and October 1<sup>st</sup>. Any person whose payment is received after the due date, shall be subject to an administrative fee of \$25.00; and


