**WHEREAS**, said Bergenline Avenue Lot is currently being utilized as a mixed use lot, providing metered parking for shoppers and monthly business permit parking for businesses during the day, as well as permit parking for permit holders during the evening between the hours of 9:00 pm and 9:00 am, Monday through Saturday and Saturday 6:00 pm through Monday 9:00 am; and

**WHEREAS**, the Commissioners of the North Bergen Parking Authority desire to extend the hours for monthly night time permit holders,

**NOW THEREFORE, BE IT RESOLVED** by the Commissioners of the North Bergen Parking Authority that, effective July 1, 2017, night time permit holders may park at the parking lot located at 7415-23 Bergenline Avenue, between the hours of 5:00 pm and 9:00 am, Monday through Saturday and Saturday 6:00 pm through Monday 9:00 am, at all other times night time permit holders are required to feed the parking meter, in said lot; and




