

RESOLUTION

NO.: 2017-044

WHEREAS, pursuant to NJS A 40:11A-6 the Parking Authority of the Township of North Bergen maintains and operates several off-street parking facilities, which are owned by the Authority or leased from the Township of North Bergen; and

WHEREAS, it is acknowledged that parking is at a premium within the Township so that the Commissioners of the Parking Authority desire that parking, offered by the Authority, be done so in as equitable a manner as possible, for the benefit of the residents of the Township,

NOW THEREFORE, BE IT RESOLVED by the Commissioners of the Parking Authority of the Township of North Bergen, that it is henceforth the policy of the Parking Authority that residents seeking to rent parking spaces within the Parking Authority's parking lots will be permitted a maximum of two spaces; and

BE IT FURTHER RESOLVED, that residents must live within four (4) blocks of a parking lot to rent space in that specific lot; and

BE IT FURTHER RESOLVED, that residents with a driveway or garage shall not be eligible to rent a space, in a Parking Authority parking lot; and

BE IT FURTHER RESOLVED, that this Resolution is effective prospectively and shall not apply in the following instances: residents that currently rent more than two spaces in a Parking Authority parking lot, while the resident maintains rental of more than two spaces; residents currently on a waiting list and residing more than four (4) blocks from the specific lot; residents who currently rent space in a lot and have a garage or driveway. This Resolution shall apply to a resident who is on the waiting list and already rents two (2) or more spaces; and


