WHEREAS, the Parking Authority of the Township of North Bergen desires to hire a contractor to repair the sidewalk fronting on the Park Avenue Lot, by replacing same; and

WHEREAS, pursuant to the Local Public Contracts Law, the Authority is required to solicit two written price quotes for said services; and

WHEREAS, the Authority solicited three quotes and obtained two written quotes, in response to its solicitation, for construction services, for repair of the sidewalk, as follows: Fisted Dove Excavating, Inc., of North Bergen, New Jersey, with a quote of \$17,975.00 and Riggi Paving, Inc., of Fairview, New Jersey, with a quote of \$19,482.00; and

WHEREAS, Fisted Dove Excavating, Inc. having submitted the price quote which is most advantageous to the Authority, price and other factors considered, the Commissioners of the Parking Authority desire to obtain the services from Fisted Dove Excavating, Inc., for repair of the sidewalk,

NOW, THEREFORE, BE IT RESOLVED, by the Commissioners of the Parking Authority of the Township of North Bergen, that the Chairman of the North Bergen Parking Authority, is hereby authorized to enter into an Agreement, as approved by the attorney for the Parking Authority, with Fisted Dove Excavating, Inc., in accordance with its quote, subject to certification of the availability of funds, in a sum not to exceed \$17,975.00, for sidewalk repair services, as set forth herein; and
