WHEREAS, Ordinance #767-99, Section 5, as amended, establishes the hours of operation for metered parking, in the Township, between the hours of 9:00 a.m. through 6:00 p.m. on Tuesday, Wednesday and Saturday and 9:00 a.m. through 9:00 p.m. Monday, Thursday and Friday, except in the area, on Kennedy Boulevard West, between 46th Street and 54th Street, where the hours of operation are from 7:00 am to 10:00 pm; and

WHEREAS, it is noted by the Parking Authority that the commercial area has expanded to the extent that most businesses are open every evening until 9:00 pm; and

WHEREAS, the Parking Authority desires to accommodate the businesses by expanding the parking hours except where noted herein, to 9:00am through 9:00 pm; and

WHEREAS, the Parking Authority further desires to address a traffic condition by implementing short term meters on Kennedy Boulevard in the area of the west side of Kennedy Boulevard West and 84th Street, between the north west corner and the northerly cross walk, with a 15 minute maximum time permitted for the parking of any vehicle,

NOW, THEREFORE, BE IT RESOLVED by the Commissioners of the Parking Authority of the Township of North Bergen, that a recommendation be sent to the Mayor and Commissioners of the Township of North Bergen requesting that the hours for meter operation established in Ordinance # 767-99, be amended, to provide for meter operation, as set forth in the above recitals; and

BE IT FURTHER RESOLVED that the attorney for the Authority be and is hereby authorized to notify the Mayor and Commissioners of the Township of North Bergen of this recommendation and to prepare a proposed Amendment to the existing Ordinances to accomplish same; and
