WHEREAS, the North Bergen Parking Authority recognizes the need for the production of a newsletter in order to educate the public on the services of the Authority and to obtain a survey of the residents to solicit the needs of the community; and

WHEREAS, the Commissioners of the Authority, at its July 16, 2014 meeting, directed that the Authority obtain quotes for the production and distribution of a newsletter; and

WHEREAS, pursuant to the Local Public Contracts Law, the Authority is required to request two written price quotes for said services; and

WHEREAS, the Authority sought five (5) quotes for the production and distribution of a newsletter and received one responsive quote for said service, from Vision Media Marketing, Inc., for the sum of \$12,450.00; and

WHEREAS, Vision Media Marketing, Inc., having submitted the price quote, which is most advantageous to the Authority, price and other factors considered, the Commissioners of the Parking Authority desire to engage Vision Media Marketing, Inc. for the production and distribution of a newsletter,

NOW, THEREFORE, BE IT RESOLVED, by the Commissioners of the North Bergen Parking Authority, that the Chairman of the North Bergen Parking Authority, is hereby authorized to enter into an Agreement, as approved by the attorney for the Parking Authority, with Vision Media Marketing, Inc., in accordance with its quote, subject to the availability of funds, in a sum not to exceed \$12,450.00, for the production and distribution of a newsletter; and


