

RESOLUTION

WHEREAS, pursuant to N.J.S.A. 40:11A-6 the North Bergen Parking Authority is authorized to provide off-street parking and to maintain and operate parking facilities under its control; and

WHEREAS, the Parking Authority maintains parking lots which are offered for parking by residents, on a monthly basis; and

WHEREAS, the Parking Authority has received requests by residents for short term off-street parking, in those instances where the resident is away from home and unable to move his/her vehicle,

NOW THEREFORE, BE IT RESOLVED by the Commissioners of the North Bergen Parking Authority, that the Parking Authority desires and will pilot a program to accommodate the short term parking needs of its residents, by providing a short duration parking permit, if and when a space is available; and

BE IT FURTHER RESOLVED that the Parking Authority shall rent the short term space at a rate of \$20.00 per week on a first come basis, not to exceed four consecutive weeks unless authorized by the Board of Commissioners and the Executive Director; and

BE IT FURTHER RESOLVED, the Parking Authority shall prepare rules and regulations to implement the purposes of this resolution; and
