

RESOLUTION

WHEREAS, the Parking Authority of the Township of North Bergen currently provides that hourly employees working less than 25 hours are employed as part-time employees; and

WHEREAS, the Parking Authority desires to increase the number of hours for hourly part-time employment to 29 hours,

NOW THEREFORE, BE IT RESOLVED, that the Commissioners of the Parking Authority of the Township of North Bergen consider that employment on a "part-time" basis shall mean all employees employed on a regularly scheduled basis for 29 hours or less per work week; and

BE IT FURTHER RESOLVED, except as otherwise provided herein, no Authority employee shall be entitled to or receive employer-paid medical benefits under the Parking Authority's health insurance policy unless employed on a regularly scheduled basis for a minimum of 35 hours per week.

BE IT FURTHER RESOLVED, employment on a "regularly scheduled basis" shall exclude all employment on a seasonal, temporary and/or casual basis and shall not include any extra hours worked by part-time employees in excess of their regularly scheduled time sporadically or due to emergencies; and
